97-5 THE VIBE'S "DISNEYLAND RESORT TEX-TO-WIN" CONTEST OFFICIAL RULES

The Station will conduct the **97-5 The Vibe's "Disneyland Resort Text-to-win"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. - 2. Contest Period. The Contest entry period will begin at 8:20am MDT on Monday, March 11, 2024 and will run through 11:59pm MDT Friday, March 29, 2024 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.**

On-Air & Text: Listen to the Station weekdays at approximately 8:20am, 12:20pm and 4:20pm MDT during the Contest Period. When the Station plays the "cue-to-text" sounder and gives the keyword, listeners should text the designated keyword spelled correctly to the Station at 520-696-3017 to enter to win. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to text later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished. All entries must be received by 11:59pm MDT on Friday, March 29, 2024 to be eligible to win. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider.

4. Winner Selection.

Qualifying Prizes: On or about 10:00am MDT weekdays from Tuesday, March 12, 2024 through Monday, April 1, 2024, Station will select one (1) entry to be eligible to win in a random drawing from among all valid entries received by Station during the Contest Period as of the date and time of that drawing (each a "Qualifier").

Grand Prize: On or about 11:00am MDT on Monday, April 1, 2024 Station will select one (1) potential Grand Prize winner in a random drawing from among all Qualifiers. The Qualifiers that do not win the Grand Prize will win a Prize.

Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within one (1) day of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize. - 5.
