THE VIBE'S "SLOW JAMS 30th ANNIVERSARY PM DRIVE GIVEAWAY" CONTEST Official Rules

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. - 4. <u>Text</u>: Listen to the Station weekdays from 2:00PM and 6:00PM PST during the Contest Period. When the Station plays the "cue-to-text" sounder, listeners should text the announced keyword into the Station at (520) 696-3017. All entries must be received by 11:59pm each weekday to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider.

Winner Selection. On or about 11:00am weekdays following each contest day, Station will select One (1) potential winner in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest. Failure to respond to the initial verification contact within one (1) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
