1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. When the Station plays the "cue-to-text" sounder, listeners should text into the Station at (520) 696-3017. All entries must be received by 11:59pm on Friday, June 21, 2024 to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider.

Winner Selection. On or about 11:00am weekdays following each contest day, Station will select One (1) potential winner in a random drawing from among all valid entries received by Station during the Contest Period. Daily winners will receive the Prize and be qualified to win the Grand Prize. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. - 6. Verification of Potential Winner.
